## NOTIFICATION

It is hereby notified to all concerned that the following amendments in the Ph.D. Ordinance have been approved by the Vice-Chancellor under section 11(6) of the University Act :

1. Full time regular teachers with Ph.D. degree working in the Government and Non-Government Aided Colleges affiliated to this University having five years' experience and at least five research publications in peer reviewed journals can be appointed as Co-supervisor through the Principal concerned. It is clarified that the Supervisor to the research scholar will be appointed from the concerned University Teaching Department only.
2. Full time teachers with Ph.D. other than those covered under Clause 8.1 of Ph.D. ordinance 2021-22 having five years continuous experience in this University with five publications in peer reviewed journals may be appointed as Co-supervisor.
3. In case of appointment of Co-supervisors, half Ph.D. seat for each candidate(s) (internal or external) shall be taken into account and will be covered within the limit of seats assigned to a teacher.
4. A Committee consisting of Dean Academic Affairs, Dean Research and Chairperson of the concerned department shall approve the name of Co-supervisor (under point No. 1 & 2 above) after verification of research publications, facilities available in his/her college and experience etc. However, the condition of facilities available will be relaxed in case of availability of alternative facilities.
5. The candidates having valid JRF may be allowed direct admission in Ph.D. programme throughout the academic session on the recommendations of the Supervisor and Chairperson. Such candidates shall complete the Ph.D. course work in the first available opportunity. The seat allotted to such candidates during one academic session will be deducted from the seats of concerned category in the next academic session to ensure the implementation of State Reservations Policy.
6. For enhancing the research output, there shall be special provision of one supernumerary Ph.D. seat per eligible supervisor for in-service teachers working in Colleges/Universities and persons in public services.

Accordingly, the request of the teacher concerned for approval as Co-supervisor may be sent on or before 28.03.2022 in the office of Dean Academic Affairs through their Chairperson/Principal. Advance soft copy of the request on email - [daa@cdlu.ac.in](mailto:daa@cdlu.ac.in) will also be entertained subject to the receipt of application through proper channel.
