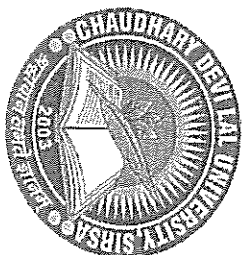

B. Registration letters issued to all the JRF/RGNF/MANF candidates who were admitted in PhD programme after the adoption/implementation of the UGC minimum standard and procedure for the award of M.Phil/PhD degree, Regulations 2009, may be amended therein reflecting the changed date of their registration in Ph.D programme- as per point 'A' above.

C. For the candidate seeking admission in PhD programme in session 2015-16, all the selected candidates - exempted from Pre-PhD course or otherwise- shall have to deposit fee applicable to them as per the schedule notified by the Department(s). For these candidates date of deposition of fee shall be considered as the date of their registration in PhD programme.

D. The date of meeting of PGBO&R shall remain relevant only for the purpose of counting the period of submission of PhD thesis for all the PhD scholars (availing fellowship of any kind or otherwise) who have been enrolled in PhD programme after adoption/implementation of the UGC minimum standard and procedure for the award of M.Phil/PhD degree, Regulations 2009.

E. There shall not be any change in the date/procedure of confirmation of the registration in PhD programme.

17. I. Noted the following action taken by the Vice-Chancellor under Section 11(6) of the University Act, for approving the recommendation of Faculty of Commerce and Management:

“The students who obtained 50% marks in individual subject and 55% marks in aggregate of all seven papers offered to them are eligible to get their B.Com (Hon’s) Degree and those who are not able to attain the required minimum percentage i.e. 50% marks in individual subject and 55%marks in aggregate will be awarded B.Com (General) Degree and the rules of B.Com. (General) Degree i.e. attaining 35% pass marks will be applicable to them. The decision would be applicable on those students also who apply for the honours course during the academic session 2014-15 too”.

in submission of synopsis by the candidate. Cases of delay exceeding one year
may be referred to Academic Council.
7. In respect of clause-60 of Ph.D. Ordinance 2015-16, it is recommended that
modification in the title/synopsis of the research problem may be allowed upto
02 years from the date of approval of topic of research by F&BOS&R
instead of date of registration.
8. Regarding exemption from Course-work, committee recommended that the
candidates who have already completed their Pre-PhD course-work from
